1. Comprehensive Plan Update

2. Variance-120 Spruce Street

McLaughlin moved to approve the request from the side and rear setbacks due to a hardship created because the laundry room has an exterior entrance with the following conditions: 1) The laundry hall addition on the NE corner be approved as requested, 2) If the deck on the NE corner is altered or expanded that the deck encroach no further on the side set back that the existing house, 3) Landscaping is required along the foundation of the additions or along property line to screen the addition. A landscape plan must be submitted with permit application prior to the permit being issued. The plan will include a minimum of 8-10 plants. The installation of the landscape plan must be inspected and verified by the City Code Enforcement officer prior to a Certificate of completion being issued. 2nd by Carlson. Approved 5-0-0.
